
Why early learning matters

In the first five years of life, children's brains are wired to learn quickly. Early learning helps to amplify their natural skills and abilities.

Young children learn best through play-based activities that are suited to their age. When children have inclusive, positive and rich early learning experiences, they are more likely to go on to become successful learners, with high levels of wellbeing. Early childhood education and care is an important way of providing learning experiences, especially for children experiencing disadvantage or vulnerability.

Early childhood educators support and extend play to maximise learning through exploration, inquiry and problem-solving. Educators also help families understand and support their child's development.

Snapshot of Australia:

- 1.3 million children attend an approved early childhood education and care service.
- 339,015 children aged four or five years were enrolled in a preschool program.
- In 2021, children who did not receive any ECEC were twice as likely to be developmentally vulnerable on one or more domains when starting school than children who received some ECEC (40.7% compared to 20.3%).
- One in three children in Australia live in 'childcare deserts' (areas where there are more than three children for every early childhood education and care service).
- The number of children (aged up to five years) using early learning services has risen over the past 10 years, from 36% in 2010 to nearly 66.5% in 2021.
- Children living in remote areas, children from Indigenous backgrounds, children from non-English speaking backgrounds, and those with a disability are under-represented in early learning services.
- As of 1 July 2022, 88% of services were rated as meeting or exceeding the National Quality Standard.
- The median weekly cost of centre-based early learning services has increased from \$423 in 2015 to \$540 in 2021.
- Australia's investment in early learning is below the Organisation for Economic Co-operation and Development (OECD) average (0.7% of GDP).
 Australia is ranked 11th among 21 OECD nations.

- Affordability of early learning: A simplified subsidy system that delivers affordable and predictable ECEC.
- **Inclusion in early learning:** Well-resourced systems and practices that put ECEC services in reach for all children and families.
- **Stability of early learning:** A well-supported and professionally-paid workforce that are thriving in their work.
