



ToR released for ACCC inquiry

The ACCC has released the ToR for its inquiry into the rising costs of operating early childhood education and care services across Australia. The final report is due by 31 December 2023, and an interim report will be delivered by 30 June 2023. Read the terms here.

The Australian Government has announced \$6.5 million of funding to set up three new facilities to address gaps in hearing services available for children with hearing loss in New South Wales and Tasmania. Learn more.

State and territory news

ACT

The ACT Government released *Best Start for Canberra's Children: The First 1000 Days Strategy*, outlining its vision for working with community and service partners to ensure early support for children and families to improve their long-term health and wellbeing. Explore here.

Applications are now open for the ACT Government's \$2 million grants to support healthy weight and activity in children and young people, as well as targeted support for social connection in priority groups. Apply now.

NSW

As part of the Australian Government's \$9 million Online Safety Grants Program, KIDS Foundation's 'Netys the Trusted eSafety Friend' program has been awarded funding worth \$381,147 to empower more children and young people to stay safe online. Read here.

The NSW Government will be investing \$23.5 million to provide aspiring early childhood educators scholarships of up to \$3,000 for Certificate III and up to \$5,000 for a Diploma qualification in early childhood education and care. Learn more.

SA

SA councils can now apply for the Local Government Early Childhood Community Innovation Grants, a one-off funding program with total funding of \$180,000 available. The grants will support councils in the delivery of evidence-informed innovation and local and community-led programs. Apply now.

TAS

The Tasmanian Government has announced 15 additional schools are to join the School Lunch Pilot Program, giving more children access to fresh, nutritious food. Details here.

Premier Jeremy Rockliff has announced a new website to publish updates and timelines around its Commission of Inquiry, which is investigating the Tasmanian Government's responses to child sexual abuse in institutional settings. Learn more.

VIC

The annual Safe Steps Walk Against Family Violence in Victoria will be held on Friday 25 November 2022, as an in-person event. By participating, supporters help promote the message across Victoria that family violence and violence against women is not okay. Learn how to get involved here.

The WA Government has committed \$100,000 in funding over 12 months for a specialised child trauma training program delivered by the Australian Centre for Child Protection Western Australia. Read more.


