Kumarninthi – Becoming one: Old ways, new wisdom

is the theme for the 35th ECA National Conference to be held at the Adelaide Convention Centre, South Australia, Wednesday 4 October to Saturday 7 October 2023.

The theme title reinforces that although we still hold on to and value old ways, theoretical perspectives and knowledge, there is and can be a contemporary approach to implementing this into new wisdom and becoming one. Kumarninthi means 'becoming one' and comes from the South Australian Kaurna people.

By using the Kaurna language in our conference theme we pay our respect to the Kaurna heritage and people of Adelaide and the Adelaide Plains.

The ECA National Conference provides a platform for professional discourse relevant to the rights, wellbeing and early education of young children (birth to eight years). It is attended by early childhood educators, teachers, service leaders and executives, as well as policy-makers, program administrators, academics, researchers and those involved in pre-qualification training and ongoing professional development.

Professor Deborah Brennan AM was appointed as an Associate

Commissioner with the Productivity Commission in February 2023 to work on the Early Childhood Education and Care inquiry.

Deborah Brennan BA Syd., MA Macq., PhD Syd., FASSA, is one of Australia's leading researchers in comparative welfare, family policy and gender and politics. Deborah is Professor Emerita at the Social Policy Research Centre, UNSW and has held visiting positions at the London School of Economics, Oxford University and Trinity College Dublin.

Deborah has served on a range of government committees and advisory bodies. She was also the Inaugural Convenor of the National Association of Community Based Children's Services (1982-1986) and has served on the boards of various research and community organisations, including the Centre for Children and Young People, Southern Cross University (2009-2020) and the Australian Council of Social Service (ACOSS) (1996-2000).

Hon Dr Anne Aly MP Minister for Early Childhood Education

Dr Anne Aly MP has been the Federal Member for Cowan since 2016 and is also the Federal Minister for Early Childhood Education and Minister for Youth in the Albanese Government.

By her late twenties, Anne was a single mother of two young boys earning the minimum wage to put food on the table. She went on to study her Masters and PhD and worked as a professor, academic and practitioner in counter terrorism and countering violent extremism. The founder of People against Violent Extremism, Anne was the only Australian representative to speak at President Obama's 2015 White House summit on countering violent extremism.

Anne is a 2011 inductee into the Western Australian Women's Hall of Fame, a 2016 nominee for Australian of the Year and a 2016 recipient of the prestigious Australian Security Medal. In 2021, she was awarded the McKinnon Prize for Emerging Political Leader of the Year, in recognition of her Parliamentary work against both right-wing extremism and family & domestic violence.

NSW & Australian Government inquiries and consultations in 2023

Thanks to ongoing advocacy by many, there are a number of inquiries and consultations taking place on the Early Childhood Education and Care (ECEC) sector to be aware of over the next year.

NSW Government

Independent Pricing and Regulatory Tribunal (IPART)

Review of Early Childhood Education and Care affordability, accessibility and consumer choice

IPART released the final Terms of Reference in February 2023. With an interim report due in August 2023 and final report due at the end of 2023, IPART is due to release an issues paper in April 2023.

Australian Government

Productivity Commission

 Inquiry into Early Childhood Education and Care sector in Australia

This inquiry examines the early childhood education and care (ECEC) sector, including centre-based day care, preschools, family day care, outside school hours care and in home care. The Commission will consider cost and availability barriers that affect access to ECEC services, and ways to support better outcomes for children and families.

With a final report to Government due in June 2024, initial submissions are now open until Friday 19 May 2023.

Australian Competition and Consumer Commission

 Inquiry into the market for the supply of childcare services

The inquiry will examine and consider matters including costs and availability of labour, the use of land and related costs, finance and administrative costs, regulatory compliance costs, the costs of consumable and the prices charged since 2018 and how these have changed following changes in childcare policy settings.

The ACCC will examine how costs and prices differ by type of provider and size, type of childcare service, age and characteristics of the child in care, geographic location, level of competition and the quality rating of the childcare services provided.

Within an interim report due in June 2023 and final report due at the end of 2023, the ACCC has indicated that they will be running a wide range of consultation and information gathering activities with selected stakeholders.

Department of Social Services

• National Early Years Strategy

The Australian Government is developing an Early Years Strategy (the Strategy) to shape its vision for the future of Australia's children and their families. The Strategy will aim to deliver the best possible outcomes for Australian children.

The Strategy will help the Commonwealth create a more integrated, holistic approach to the early years and better support the education, wellbeing and development of Australia's children. It will seek to support improving coordination between Commonwealth programs, funding and frameworks impacting early childhood development.

The Discussion Paper is open for public submissions until 30 April 2023.

Department of Education

Draft National ECEC Vision

National Cabinet has asked the Australian Government in collaboration with state education and early years ministers to develop a national long-term vision for early childhood education and care. The vision will support parents' workforce participation and children's education and development outcomes.

The draft national vision covers all forms of ECEC, including preschool and all forms of child care.

Consultation via a survey or submission ended on 7 April 2023.
